We believe our pets are an integral part of our lives, they provide un-conditional love & should be treated as part of the family. We are very serious about our mission and want to ensure they have a better quality of life so we ask that the adopters agree to the following conditions:

I promise to provide a safe, secure, humane pet friendly home, and never to abuse / neglect / mistreat or abandon \_\_\_\_\_ (Abandonment of an animal is actually illegal) \_\_\_\_\_

I promise to provide adequate food, water, shelter, exercise and not allow the dog to be a "backyard", "garage" dog, or "chain dog", (tethering more than 3 hours is illegal.) \_\_\_\_\_

I promise to provide appropriate vet care (vaccinations, annual exams, heartworm testing, etc). Pattie's Angels can provide recommendations for vets or low cost clinics. \_\_\_\_\_

If I find the dog / animal develops serious behavioral issues we will contact the rescue organization immediately and will consult with a trainer to see if the issues can be remedied before returning the dog. (Patties Angels can provide a list of trainers). \_\_\_\_\_

I understand it is my responsibility to provide proper identification tags and licensing. Having proper identification can help save their lives, and prevent pets from falling into the wrong hands or ending up at a shelter. The rescue will also provide an I D tag which is required to be kept on the animal at all times (except for grooming of course!) \_\_\_\_\_

If my rescue dog / animal becomes LOST, we will IMMEDIATELY contact the rescue organization for assistance and that we will do everything in our power to help find them including posting flyers, contacting local shelters and newspapers, & alerting neighbors \_\_\_\_\_

Our philosophy is that it's a commitment to adopt an animal and that adoptions should be FOR LIFE ! However we also understand that un-foreseen problems can arise. We will try and provide some support during hard-times, including food . But if you have a TRUE hardship and are no longer able to care for the animal, or the animal is having serious behavioral issues, we need you to provide us with 3 weeks notice to make proper arrangements to have our dog/animal returned. Also, it is not allowed to surrender any of our animals to a shelter, another rescue organization OR to euthanize our rescues except for life-threatening medical pain and suffering (we need to be notified first). Nor can they be transferred to another home / family without approval but we will do our best to see if alternative arrangements can be made. Any violation of this policy will be considered a legal BREACH OF CONTRACT \_\_\_\_\_

Our goal is to ensure they live a long and healthy life and we wish to provide a safety net for all our animals whenever possible so we may periodically do a welfare check. That's usually just a phone call or an email but the adoptions are "conditional" and if the rescue discovers the terms & conditions are NOT being upheld, and / or the animal is in poor-conditions we reserve the legal right to ask for the dog/animal to be returned back to the organization \_\_\_\_\_

All dogs/animals adopted thru a rescue MUST be Spayed / Neutered by law. If the dog / animal is not fixed yet, we have a FOSTER-TO-ADOPT program which will allow him / her to be fostered until we can make the appointment at one of our low cost clinics. Upon being spayed /neutered the adoption can be finalized. This also allows time to get to know the dog!
